RESOLUTION NUMBER R- 281270

ADOPTED ON DEC 08 1992

BE IT RESOLVED, by the Council of The City of San Diego, that the recommendations of the City Manager, the City Attorney and the Planning Department regarding election of officers to the Torrey Pines Community Planning Group, as contained in Manager's Report No. P-92-278, are hereby approved as follows:

1. The Torrey Pines Community Planning Group should elect new officers after the regular election scheduled in March, 1993.

2. The Torrey Pines Community Planning Group should elect ten members at the regular election scheduled in March, 1993.

BE IT FURTHER RESOLVED, that the following conditions are added:

1. The Planning Department shall schedule its orientation workshop for the Torrey Pines Community Planning Group immediately after the March 1993 election.

2. The Torrey Pines Community Planning Group shall amend its bylaws, within ninety days following the March 1993 election, to clarify its membership qualifications and election procedures and to be in full compliance with Council Policy 600-24.

3. The planning group should consider utilizing, on a voluntary basis, the services of the community mediation




