RESOLUTION NUMBER R- 281725

ADOPTED ON APR 12 1993

WHEREAS, on June 1, 1991 there were two stabbing deaths in the Ventura Cove/Bonita Cove area and the San Diego Police Department began closing the public parking lots from 10:00 p.m. to 6:30 a.m.; and

WHEREAS, the City Manager thereafter increased the level of police enforcement in the area for the summer months and directed that at certain parking lots gates be installed to prohibit ingress between 10:00 p.m. and 6:30 a.m.; and

WHEREAS, the City Council authorized the City Manager to apply for a Coastal Development Permit from the California Coastal Commission for nighttime gating of the parking lots; and


WHEREAS, the California Coastal Commission approved the application and required that further action by the Coastal Commission would be necessary to extend the lot closures beyond July 16, 1993; and

WHEREAS, since June 1, 1991, when the parking lots at Ventura Cove, Bahia Point and Bonita Cove were closed and subsequently gated at night, San Diego Police Department statistics reflect a drastic reduction in crime in these areas; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to request an amendment from the California Coastal Commission to an existing Coastal Development Permit to delete the July 16, 1993 expiration date for

the nighttime, gated closure of the parking lots at Ventura Cove,
Bahia Point, and Bonita Cove in Mission Bay Park.
