## ordinance number o-17032 (NEW SERIES) ADOPTED ON FEB 221988

AN ORDINANCE INCORPORATING PROPERTY LOCATED AT THE SOUTHWEST QUADRANT OF AERO DRIVE AND INTERSTATE 15, IN THE SERRA MESA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO THE M-1B ZONE, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 101.0435.2, AND INCREMENTALLY REPEALING ALL PRIOR ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That certain property zoned R1-40,000 and M-1A located south of Aero Drive and west of Interstate 15, in the Serra Mesa Community Plan area, in the City of San Diego, California, within the boundary of the district designated "M-1B" on Zone Map Drawing No. B-3861, filed in the office of the City Clerk as Document No. 217032, be, incrementally, upon approval of individual final subdivision maps, incorporated into the M-1B Zone, as such zone is described and defined by San Diego Municipal Codes Section 101.0435.2.

Section 2. That, upon approval of final subdivision maps consistent with the Stonecrest Specific Plan, all prior ordinances of The City of San Diego will be incrementally repealed insofar as they conflict herewith.

Section 3. This ordinance shall incrementally take effect and be in force on the thirtieth (30th) day after City Council adoption of individual final subdivision maps within the specific

plan area; however, no building permits for development inconsistent with the provisions of the adopted Stonecrest Specific Plan shall be issues.
