AN ORDINANCE AMENDING CHAPTER X, ARTICLE 1, DIVISION 5, OF THE SAN DIEGO MUNICIPAL CODE BY ADDING SECTION 101.0517 RELATING TO CONDITIONAL USE PERMITS FOR NEW RESEARCH, DEVELOPMENT AND DEMONSTRATION HAZARDOUS WASTE FACILITIES.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 1, Division 5, of the San Diego Municipal Code be and the same is hereby amended by adding Section 101.0517 to read as follows:

# SEC. 101.0517 CONDITIONAL USE PERMIT FOR NEW RESEARCH, DEVELOPMENT AND DEMONSTRATION HAZARDOUS WASTE FACILITIES

## A. APPLICABILITY

Any conditional use permit sought pursuant to Section 101.0510(c)(4)(j) shall comply with the applicable provisions of this section, which are supplementary to and in the event of conflict shall supersede the regulations set forth in Section 101.0510.

### B. APPLICATION - FORM AND CONTENT

An application for a permit for a conditional use referred to in this section shall be made as specified in Section 101.0510.D.

#### C. NOTICING PROCEDURE

Noticing procedure for both the Planning Commission hearing (Subsection D. below) and City Council hearing (Subsection E. below) shall be governed by Section 101.0510.E.

D. RECOMMENDATION OF PLANNING COMMISSION TO CITY COUNCIL

The Planning Commission shall hold a public hearing and make a recommendation to the City Council pursuant to the provisions in Section 101.0510.F. within ninety (90) days after a conditional use permit application is filed and accepted as complete unless requisite environmental documents have not become final. If requisite environmental documents have not become final at the time of submittal of the conditional use permit application, the period specified herein shall not commence to run until such documents have become final.

#### E. ACTION OF THE DECISIONMAKER

Within thirty (30) days after the Planning
Commission's recommendation to the City Council, the
City Council shall conduct a noticed hearing and shall
render a final decision granting or denying the
conditional use permit pursuant to Section 101.0510.G.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
