ADOPTED ON MAR 14 1988

AN ORDINANCE AMENDING CHAPTER II, ARTICLE 2,  
OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING  
SECTION 22.1801 RELATING TO THE DEPARTMENTS OF  
THE CITY OF SAN DIEGO.

WHEREAS, it has been recommended that a new department be established, to be called Department of Waste Management, to focus the City's efforts on waste reduction and management; and

WHEREAS, the department will be the result of a reorganization and move of all personnel and equipment presently authorized for such duties and responsibilities; and

WHEREAS, the Rules Committee discussed the matter on February 3, 1988 and voted 4-1 to approve the recommendation, District 1 voting nay; and

WHEREAS, it is now appropriate to forward the matter to the full Council for necessary Municipal Code amendatory action; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter II, Article 2, Section 22.1801 of the San Diego Municipal Code be and the same is hereby amended to read as follows:


