SEC. 71.103 Phasing

This Division shall be implemented in phases as follows:

- A. Intermediate Employer Phasing for
 Intermediate Employers shall be effective four years
 and six months from the Implementation Date.
 - B. through D. [No changes to these subsections]

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
