ADOPTED ON FFB 22 1993

AN ORDINANCE REZONING APPROXIMATELY 60.0 ACRES LOCATED EAST OF INTERSTATE 5 AND APPROXIMATELY ONE QUARTER MILE SOUTH OF CARMEL VALLEY ROAD ON EL CAMINO REAL, IN THE SORRENTO HILLS COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, FROM THE A1-1 ZONE INTO THE CO ZONE, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 101.0423, AND REPEALING ORDINANCE NO. 0-10936 (NEW SERIES), ADOPTED OCTOBER 5, 1972, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

WHEREAS, this Council adopted Resolution Nos. R281472,

R-281471 and R-281470 on FEB 09 1993 1993, for Vesting

Tentative Map No. 85-0824 and Planned Commercial

Development/Coastal Development Permit No. 85-0824 ("PCD/CD permit") for the Torrey Reserve Project; and

WHEREAS, the Torrey reserve project consists of approximately 60.8 acres located east of Interstate 5 approximately one quarter mile south of Carmel Valley Road on El Camino Real, in the Sorrento Hills Community Planning Area, in the City of San Diego, California; and

WHEREAS, as a condition of approval of the PCD/CD permit, this rezoning is not to become effective until a final subdivision map for the Torrey Reserve Project is filed with the Recorder of the County of San Diego; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the areas designated "CO" on Zone Map
Drawing No. B-4010, on file in the office of the City Clerk as
Document No. 00-17895, are rezoned, subject to the provisions
of Section 2 of this ordinance, from the A1-1 zone to the CO
zone, as described and defined by San Diego Municipal Code
section 101.0423.

Section 2. That this rezoning shall become effective upon the recordation of a final subdivision map or maps for the Torrey Reserve Project in the Office of the Recorder for the County of San Diego. Said zoning shall attach only to those areas included within a recorded final subdivision map or maps.

Section 3. That, in the event the said final map is not recorded within ten (10) years following the adoption of this ordinance, this ordinance shall be and become void and of no further force or effect.

Section 4. That in the event the zoning restrictions shall attach to the said land described in Section 1 of this ordinance, Ordinance No. O-10936 (New Series), adopted October 5, 1972, shall be automatically repealed insofar as it conflicts with the rezoned uses of such land.

Section 5. This ordinance shall take effect and be in force on the thirtieth day from and after its passage; however, the

provisions of this ordinance shall not be applicable within the Coastal Zone until the California Coastal Commission certifies this ordinance as a Local Coastal Program amendment.
