## ORDINANCE NUMBER O- 17896 (NEW SERIES) ADOPTED ON FEB 22 1993

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the City Manager is hereby authorized and empowered to execute, for and on behalf of said City, a second amendment to the agreement of July 23, 1990 with the San Diego Unified School District, for construction, maintenance and lease of turfed field and recreation facilities at Adams Elementary School, under the terms and conditions set forth in the Second Amendment to Agreement on file in the office of the City Clerk as Document No. 00-17896, together with any reasonably necessary modifications or amendments thereto which do not increase this project's scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

Section 2. That the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$8,000 from Mid-City Park Development Fund No. 39094 to CIP No. 29-710.0, Adams Avenue Park - Development.

Section 3. That the expenditure of an amount not to exceed \$8,000 from CIP No. 29-710.0, Adams Avenue Park - Development, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.

Section 4. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
