ADOPTED ON APR 12 1993

AN ORDINANCE AMENDING SECTION 5 OF ORDINANCE
NO. O-17577 (NEW SERIES), ADOPTED JANUARY 9,
1991, RELATING TO PACIFIC BEACH REZONING

BE IT ORDAINED, by the Council of The City of San Diego, as
follows:

Section 1. That Section 5 of Ordinance No. O-17577 (New
Series), adopted January 9, 1991, be and the same is hereby
amended to read as follows:


Section 5. Within the Coastal Zone, no permits
for development inconsistent with provisions of this
ordinance shall be issued unless release from the
provisions of the Single Family Protection ordinance
was denied prior to November 20, 1990, or application
for development was submitted prior to November 20,
1990. The zoning (land use) regulations applicable at
the time application was made or at the time release
from the Single Family Protection ordinance was denied
shall be the zoning regulations applicable with regard
to permits for a project. No permits for development
inconsistent with the provisions of this ordinance
shall be issued in any event after September 30, 1993.

Section 2. All other provisions of said Ordinance No. O-17577 shall remain in full force and effect.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, however, the provisions of this ordinance shall not be applicable within the Coastal Zone until the date the California Coastal Commission unconditionally certifies this ordinance as a local coastal program amendment. If this ordinance is not certified, or is certified with suggested modifications by the California Coastal Commission, the provisions of this ordinance shall be null and void within the Coastal Zone.
