
AN ORDINANCE AUTHORIZING A NINETY-NINE (99) YEAR LEASE AGREEMENT WITH AFJR PARTNERSHIP FOR A RESTROOM FACILITY IN THE GASLAMP QUARTER PARK.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

That the City Manager is hereby authorized to execute, for and on behalf of The City of San Diego, a Ninety-Nine (99) year lease agreement with AFJR Partnership for a restroom facility in the Gaslamp Quarter Park under the terms and conditions set forth in that lease agreement on file in the office of the City Clerk as Document No. OO- 17907
