
AN ORDINANCE AUTHORIZING A MASTER LEASE AGREEMENT TO PROVIDE FOR THE FINANCING OF CERTAIN CITY EQUIPMENT.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the City Manager is hereby authorized to execute, for and on behalf of The City of San Diego, a ten (10) year Master Lease Agreement with Koch Financial for three (3) and four (4) year lease terms, and with GE Capital Public Finance for five (5) and seven (7) year lease terms to provide for the financing of certain City equipment, under the terms and conditions set forth in the Master Lease Agreement on file in the office of the City Clerk as Document No. OO- 17908-1 and 20-17908-2

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
