WHEREAS, the Municipal Code, as it has been developed and numbered over the years, has numerous inconsistent or inappropriate numbers allocated to various chapters, articles, divisions and sections; and

WHEREAS, the numbers themselves are nonsubstantive and it is desirable to allow the City Attorney, in consultation with the City Clerk and other affected departments, to modify the numbers without bringing such modifications forward to the City Council in each case for approval; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter I, Article 1, Division 2, of the San Diego Municipal Code be and the same is hereby amended by adding Section 11.0207 to read as follows:

SEC. 11.0207 NUMBERING OF MUNICIPAL CODE CHAPTERS, ARTICLES, DIVISIONS AND SECTIONS

The City Attorney, in consultation with the City Clerk and other affected departments, is hereby granted the authority to establish and modify, as necessary, the numbers
