AN ORDINANCE AMENDING CHAPTER II, ARTICLE 2, DIVISION 1, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 22.0101, ENTITLED "PERMANENT RULES OF THE COUNCIL" BY AMENDING RULE 21 RELATING TO THE "COMMITTEE ON PUBLIC SERVICES AND SAFETY.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter II, Article 2, Division 1 of the San Diego Municipal Code be and the same is hereby amended by amending section 22.0101, Rule 21, entitled "COMMITTEE ON PUBLIC SERVICES AND SAFETY," to read as follows:

RULE 21. COMMITTEE ON PUBLIC SERVICES AN SAFETY

There is a Committee on Public Services and Safety composed of five (5) voting members consisting of five (5) Council members appointed in accordance with the provisions of Rule 13.

No changes in the last three paragraphs.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
