ORDINANCE NUMBER O- 17912 (NEW SERIES)

ADOPTED ON MAY 17 1993

AN ORDINANCE INCORPORATING THE SOLAR TURBINES, INC. PROPERTY WITHIN THE KEARNY MESA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, FROM THE M1-B ZONE INTO THE ML-I ZONE, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 101.0434.1, AND REPEALING ORDINANCE NO. O-12343 (NEW SERIES), ADOPTED MAY 1, 1978, INSOFAR AS THE SAME CONFLICT(S) HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the property, located at 4242 Ruffin Road, south of Balboa Avenue, further described as Parcel 2 of Parcel Map 14093, within the Kearny Mesa Community Plan area, in the City of San Diego, California, within the boundary of the district designated "M1-B" on Zone Map Drawing No. B-4011, filed in the office of the City Clerk as Document No. 00-17912, be, and it is hereby incorporated into ML-I Zone, as such zone is described and defined by San Diego Municipal Code Section 101.0434.1.


Section 2. That Ordinance No. O-12343 (New Series), adopted May 1, 1978, of the ordinances of The City of San Diego be and it is repealed insofar as the same conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth (30th) day from and after its passage, and no building permits for development inconsistent with the provisions

of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
