ADOPTED ON JUN 01 1993

AN ORDINANCE AMENDING CHAPTER VI, ARTICLE 2, DIVISION 1, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 62.0111 RELATING TO BONDS.

WHEREAS, May 18, 1993, has been declared "Regulatory Relief Day"; and

WHEREAS, one purpose of Regulatory Relief Day is to streamline and consolidate, where appropriate, the City's land use and environmental regulatory procedures; and

WHEREAS, the Building Inspection Department has reviewed San Diego Municipal Code section 62.0111 having to do with bonds, and has suggested several amendments to the code section to streamline the regulatory process; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VI, Article 2, Division 1, of the San Diego Municipal Code be and the same is hereby amended by amending Section 62.0111, to read as follows:

SEC. 62.0111 Bond Required

Persons performing work under Grading, Encroachment, Public Improvement, or Driveway permits issued in accordance with this Article shall furnish a performance and materialman's bond, cash deposit or other form of security acceptable to the Permit Issuing Authority in accordance

with the following provisions:

(a) through (e) [No changes to these subsections]

(f) No bond under the provisions of this Article shall be required for: 1) any work performed by the State of California, any of its political subdivisions or any governmental agency; or 2) where the estimated cost of the work authorized by the permit is less than or equal to \$50,000.

(g) and (h) [No changes to these subsections]

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
