AN ORDINANCE AMENDING CHAPTER VI, ARTICLE 5, DIVISION 2, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 65.0216 RELATING TO NOTICE OF HEARING TO PROPERTY OWNERS.

WHEREAS, May 18, 1993, has been declared "Regulatory Relief Day," and $\stackrel{\smile}{}$

WHEREAS, one purpose of Regulatory Relief Day is to streamline and consolidate where appropriate, the City's land use and environmental regulatory procedures; and

WHEREAS, the Engineering and Development Department has reviewed Section 65.0216, of the San Diego Municipal Code having to do with the noticing of hearing to property owners, and has suggested that Section 65.0216, be amended to streamline the regulatory process; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VI, Article 5, Division 2, of the San Diego Municipal Code be and the same is hereby amended by amending Section 65.0216 to read as follows:

SEC. 65.0216 Notice of Hearing to Property Owners

Proceedings under Chapter 3 of the Landscaping and Lighting Act of 1972 shall include notice by the City Clerk to property owners owning lots of parcels in the following categories:

A. through C. [No changes.]

Notwithstanding the provisions of Government Code section 54954.6, publication of the notice of hearing shall be completed at least ten (10) working days prior to the date of hearing specified in the notice. There shall be only one noticed hearing required for the formation of a district or the levy of assessments under these proceedings.

Section 2. That this ordinance shall take effect and be in force on the thirtieth day from and after its passage.
