AN ORDINANCE AMENDING CHAPTER X, ARTICLE 1, DIVISION 6, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 101.0608 RELATING TO TEMPORARY NONCONFORMING USES IN RESIDENTIAL ZONES.

WHEREAS, May 18, 1993, has been declared "Regulatory Relief Day"; and

WHEREAS, one purpose of Regulatory Relief Day is to streamline and consolidate, where appropriate, the City's land use and environmental regulatory procedures; and

WHEREAS, the Planning Department has reviewed San Diego Municipal Code section 101.0608 having to do with temporary nonconforming uses in residential zones, and has suggested several amendments to the code section to streamline the regulatory process; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 1, Division 6, of the San Diego Municipal Code be and the same is hereby amended by amending Section 101.0608, to read as follows:

SEC. 101.0608 Temporary Nonconforming Uses in Residential Zones

The Zoning Administrator may approve or deny in accordance with "Process One," a temporary nonconforming use such as a carnival on residentially-zoned, publically-owned

land provided the use is limited to forty-eight (48) hours and occurs no more than twice a year on a given site.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
