AN ORDINANCE AMENDING CHAPTER V, ARTICLE 5, DIVISION 3, OF THE SAN DIEGO MUNICIPAL CODE BY ADDING SECTION 55.0314.0108 RELATING TO AN ADMINISTRATIVE PENALTY BEING IMPOSED RELATING TO FALSE FIRE ALARMS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter V, Article 5, Division 3, of the San Diego Municipal Code be and the same is hereby amended by adding Section 55.0314.0108 to read as follows:

SEC. 55.0314.0108 ADMINISTRATIVE PENALTY FOR FALSE FIRE ALARM

- U.F.C. 14.108 (1991 Edition) is hereby adopted and amended to read as follows:
- (a) Purpose and Intent. The City Council has determined that poorly maintained or malfunctioning fire alarm systems offer decreased fire protection to the occupants of a facility. Council has also determined that when a fire company responds to a false alarm, the same crew is unable to respond to actual emergency calls. Therefore, as a means of encouraging compliance with regulations requiring maintenance of alarm systems, an administrative penalty schedule is hereby established.
 - (b) Standby Fire Personnel. In the event of a

temporary failure of an alarm system or an excessive number of false alarms, the Fire Chief may order the building owner or occupant to provide standby fire personnel described by section 55.0425.0117 until the system is restored.

- (c) Proper Maintenance. The following is an administrative penalty schedule that will encourage proper maintenance of fire protection alarm devices:
 - Upon determination by a responding fire company that an incident was a false fire alarm due to a poorly maintained or malfunctioning fire alarm system, the Fire Chief may issue a notice to the owner or occupant that the system is malfunctioning and that continued false fire alarm incidents may result in the imposition of an administrative penalty by the Fire Department. The Fire Chief may impose an administrative penalty against the owner or occupant resulting from the City responding to a false fire alarm. More than three (3) false fire alarms in twelve (12) calendar months may result in an administrative penalty being imposed by the City for responding to the false fire alarm.
 - (2) The Fire Chief shall establish an administrative penalty schedule based upon(a) the type of structure, (b) the number of

fire units that respond to a false fire alarm, (c) the number of smoke detectors within the structure, and (d) the number of false fire alarms in a twelve (12) calendar month period. The schedule shall be determined by the Fire Chief after an annual review by, and in consultation with, the City Manager. This administrative penalty schedule shall be promulgated in the City Clerk Composite Rate Book and shall be exclusive of any other costs or fees required under any other section of the San Diego Municipal Code or the U.F.C. (1991 Edition).

- (d) Administrative Procedure. The Fire Chief shall adopt an Administrative Procedure entitled "False Fire Alarms" to assist the Fire Department in implementing section 55.0314.0108. These administrative procedures shall be reviewed annually by the Fire Department.
- (e) Appeal Process. An appeal process shall be promulgated in the Fire Department's Administrative Procedure entitled "False Fire Alarms", which will provide an opportunity for a building owner or occupant who disagrees about the cause of the false fire alarm to appeal the determination to the City Manager.

This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

- (a) Purpose and Intent. The City Council has determined that poorly maintained or malfunctioning fire alarm systems offer decreased fire protection to the occupants of a facility. Council has also determined that when a fire company responds to a false alarm, the same crew is unable to respond to actual emergency calls. Therefore, as a means of encouraging compliance with regulations requiring maintenance of alarm systems, an administrative penalty schedule is hereby established.
- (b) Standby Fire Personnel. In the event of a temporary failure of an alarm system or an excessive number of false alarms, the Fire Chief may order the building owner or occupant to provide standby fire
