ADOPTED ON JUN 07 1993

AN ORDINANCE AMENDING ORDINANCE NO. O-17881 (NEW SERIES) ADOPTED DECEMBER 8, 1992, TO EXTEND THE TIME PERIOD FOR EXECUTION OF THE AMENDED AND RESTATED DEVELOPMENT AGREEMENT BETWEEN THE CITY OF SAN DIEGO AND CATELLUS DEVELOPMENT CORPORATION.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:


Section 1. That Section 3 of Ordinance No. O-17881 (New Series) adopted December 8, 1992, be and the same is hereby amended to read as follows:

Section 3. The Council hereby approves the Amended and Rested Development Agreement with Catellus Development Corporation, a copy of which is on file in the office of the City Clerk as Document No. OO-17881, including (1) the Insert to Amended and Restated Owner Participation Agreement and Development Agreement, and (2) the change of the word "shall" to "may" on the portion of the agreement which references the reconstruction of the forecourt arcades, and authorizes and directs the City Manager to execute said Amended and Restated Development Agreement in the name of The City of San Diego. The City Clerk is directed to record said Amended and Restated Development Agreement and Ordinance No. O-17881 (New Series) and this Amendment to Ordinance No. O-17881 (New Series)

immediately following the adoption of this Amendment to
Ordinance No. O-17881 (New Series).

Section 2. This ordinance shall take effect and be in force
on the thirtieth day from and after its passage.
