ORDINANCE NUMBER O- 17939 (NEW SERIES)


ADOPTED ON JUL 12 1993

BE IT ORDAINED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of the City, a twenty-five (25) year joint use agreement with the San Diego Unified School District for construction, operation, maintenance, and lease of turf field and recreation facilities at Sherman Elementary School, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. OO- 17939 .

BE IT FURTHER ORDAINED, that the expenditure of an amount not to exceed \$250,000 from CIP No. 29-791.0, Sherman Elementary School, CDBG Fund 18528/4024, is hereby authorized, solely and exclusively to design and construct improvements in accordance with the above agreement.

BE IT FURTHER ORDAINED, that this ordinance shall take effect and be in force on the thirtieth day from and after its passage.
