ORDINANCE NUMBER O-17948 (NEW SERIES)

ADOPTED ON AUG 02 1993

AN ORDINANCE CALLING A GENERAL MUNICIPAL ELECTION IN THE CITY OF SAN DIEGO ON TUESDAY, NOVEMBER 2, 1993.

WHEREAS, in accordance with paragraph 3 of San Diego City Charter section 12, as amended by the voters on November 3, 1992, Councilmembers for Districts 1, 3, 5, and 7 shall be chosen by the electors at the Municipal Primary and General Elections in 1993 for a term of three (3) years; and

WHEREAS, at a meeting held on August 2, 1993, the City Council of the City of San Diego adopted Resolution No. R-282449, requesting the Board of Supervisors of the County of San Diego to order the consolidation of the General Municipal Election to be held on November 2, 1993, with the Statewide Special Election to be held on the same date; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. It is hereby ordered that a General Municipal Election will be held in the City of San Diego on Tuesday, November 2, 1993, for the purpose of electing candidates for the following offices, unless such candidates have been elected in the Municipal Primary Election:

- COUNCILMEMBER for District No. 1 three-year term
- COUNCILMEMBER for District No. 3 three-year term

COUNCILMEMBER for District No. 5 three-year term

COUNCILMEMBER for District No. 7 three-year term

Section 2. The General Municipal Election called for November 2, 1993, in the City of San Diego is hereby ordered consolidated with the Special Statewide Election to be held on the same date.

Section 3. For the purpose of said election, the election precincts shall be the precincts established by the Board of Supervisors of the County of San Diego; provided, however, that certain said precincts shall be consolidated in the manner indicated on the list of consolidated precincts on file in the office of the City Clerk.

Section 4. The polls for said election shall be open from 7 a.m. until 8 p.m. on Tuesday, November 2, 1993.

Section 5. The City Clerk is hereby directed to cause this ordinance to be published once in the official newspaper of The City of San Diego.

Section 6. Pursuant to Section 17 of the Charter of the City of San Diego, this ordinance shall take effect on the date of its adoption.
