ORDINANCE NUMBER O-17949

ADOPTED ON AUG 02 1993

AN ORDINANCE OF THE CITY OF SAN DIEGO, CALIFORNIA, ORDERING, CALLING, PROVIDING FOR AND GIVING NOTICE OF A SPECIAL GENERAL MUNICIPAL ELECTION TO BE HELD IN COUNCIL DISTRICT 8 ON NOVEMBER 2, 1993.

WHEREAS, a Special Election was held in Council District Eight (8) on February 16, 1993, for the purpose of filling a vacancy in the office of Councilmember; and

WHEREAS, the person elected at the Special Election to fill the vacancy shall hold office only until the next regular Municipal Election, at which time a person shall be elected under the provisions of Charter section 10 to serve for the remainder of the unexpired term, that is, until December 4, 1995; and

WHEREAS, the next regular Municipal Election will be September 21, 1993 and, if necessary, November 2, 1993; and

WHEREAS, at a meeting held on August 2, 1993, the City Council of the City of San Diego adopted Resolution No.

R-282449, requesting the Board of Supervisors of the County of San Diego to order the consolidation of the Special General Municipal Election to be held on November 2, 1993, with the Statewide Special Election to be held on the same date; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, California, as follows:

Section 1. It is hereby ordered that a Special General Municipal Election be held in Council District Eight (8) on

Tuesday, November 2, 1993, for the purpose of electing the Councilmember for District No. 8, unless such candidate has been elected in the Special Municipal Primary Election.

Section 2. The Special General Municipal Election called for November 2, 1993, in the City of San Diego, if it is required to be held, is hereby ordered consolidated with the Special Statewide Election to be held on the same date.

Section 3. For the purpose of said election, the election precincts shall be the precincts established by the Board of Supervisors of the County of San Diego; provided, however, that certain said precincts shall be consolidated in the manner indicated on the list of consolidated precincts on file in the office of the City Clerk.

Section 4. The polls for said election shall be open from 7 a.m. until 8 p.m. on Tuesday, November 2, 1993.

Section 5. The City Clerk is hereby directed to cause this ordinance to be published once in the official newspaper of The City of San Diego.

Section 6. Pursuant to Section 17 of the Charter of The City of San Diego, this ordinance shall take effect on the date of its adoption.
