AN ORDINANCE MODIFYING THE REQUIREMENT OF CHAPTER VI, ARTICLE 2, SECTION 62.0208(J) OF THE SAN DIEGO MUNICIPAL CODE RELATING TO THE GENESEE AVENUE/NORTH TORREY PINES ROAD COST REIMBURSEMENT DISTRICT.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VI, Article 2, Section 62.0208(j) of the San Diego Municipal Code be and the same is not to be applicable to the Genesee Avenue/North Torrey Pines Road Cost Reimbursement District, however the following paragraph shall be the applicable standard for the initiation of applicability of the ordinance to a permit within this district:

Payment of a reimbursement charge or assessment shall not be required in connection with building permits issued for improvements which repair or modify an existing facility, but do not expand the size or capacity of the facility.

Section 2. That this ordinance shall take effect and be in force on the thirtieth day from and after its passage.
