ORDINANCE NUMBER O- 17963 (NEW SERIES)

ADOPTED ON SEP 07 1993

AN ORDINANCE INCORPORATING 0.8 ACRES LOCATED AT 2751 THROUGH 2779 A STREET, IN THE GOLDEN HILL PLANNED DISTRICT WITHIN THE GREATER GOLDEN HILL COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, FROM THE GH-2500 INTO THE GH-1500 ZONE, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 103.0711, AND REPEALING ORDINANCE NO. O-17382 (NEW SERIES), ADOPTED OCTOBER 30, 1989 OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:


Section 1. That 0.8 acres, located at 2751 through 2779 A Street and described as Lots 4 through 13 of Block 59 of H.M. Higgins Addition in the City and County of San Diego according to the Map thereof No. 309, in the Greater Golden Hill Community Plan area, in the City of San Diego, California, within the boundary of the district designated "GH-2500" on Zone Map Drawing No. B-4007, filed in the office of the City Clerk as Document No 00-17963, be and it is hereby incorporated into the GH-1500 zone, as such zone is described and defined by San Diego Municipal Code section 103.0711.

Section 2. That Ordinance No. O-17382 (New Series), adopted October 30, 1989, of the ordinances of The City of San Diego be and it is repealed insofar as the same conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building

permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
