BE IT ORDAINED, by the Council of The City of San Diego, as follows:



**SEC. 103.0702 Boundaries**

The regulations which follow shall apply in the Golden Hill Planned District which is within the boundaries of the Golden Hill community planning area in the City of San Diego, California, designated on that certain Map No. C-856, and described in the appended boundary description filed in the office of the City Clerk under Document No. 00- 17964

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
