

ORDINANCE NUMBER O-17966 (NEW SERIES)

ADOPTED ON SEPTEMBER 7, 1993

AN ORDINANCE AMENDING THE MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF SAN DIEGO AND THE METROPOLITAN TRANSIT DEVELOPMENT BOARD, CITY DOCUMENT NO. OO-15881 AND MTDB NO. L5506.0-90.

WHEREAS, on October 24, 1978 the City Council, by Resolution No. 222092 approved in concept the early implementation of a Light Rail System ("LRT") as proposed by the San Diego Metropolitan Transit Development Board ("MTDB") and approved in concept the alignment for the LRT in The City of San Diego from the Santa Fe Depot at "C" Street and Kettner Boulevard, east to 12th Avenue on "C" Street, then south along 12th Avenue and the San Diego and Arizona Eastern Railway right-of-way to the International Border at San Ysidro; and

WHEREAS, on November 23, 1981, MTDB adopted Resolution No. 81-120 which adopted an eastern light rail transit extension known as the East Urban Line which follows the San Diego and Arizona Eastern (SD&AE) trackway from 13th Street and Commercial east on Commercial to 32nd Street, then along SD&AE right-of-way; and

WHEREAS, on January 3, 1983, an ordinance was adopted authorizing the San Diego MTDB to utilize certain portions of the streets of The City of San Diego pursuant to Sections 103.1 and 105 of the San Diego City Charter for the purpose of constructing and operating an LRT extension known as the Old Town Line which follows the existing Atchison, Topeka and Santa Fe Railroad

right-of-way from Grape Street north along California Street to the San Diego River; and


WHEREAS, the Memorandum of Understanding, San Diego City Document No. 00-15881 and MTDB Document No. L5506.0-90, dated January 3, 1983 sets out the terms and conditions of constructing and operating the LRT extension known as the Old Town Line as agreed between the San Diego MTDB and The City of San Diego; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, that the Memorandum of Understanding be amended as follows:

Section 1. That the revised Memorandum of Understanding dated September 7, 1993, on file in the office of the City Clerk as Document No. 00-17966, be and by this reference is made an integral part hereof and is hereby approved. The City Manager of The City of San Diego is hereby authorized and empowered to execute the revised Memorandum of Understanding on behalf of The City of San Diego.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
