AN ORDINANCE REPEALING INTERIM ORDINANCE NO. O-17167 (NEW SERIES) ADOPTED OCTOBER 24, 1988, WHICH ENACTED AN INTERIM ORDINANCE LIMITING THE ISSUANCE OF BUILDING PERMITS AND COMMENCEMENT OF CONSTRUCTION WITHIN A PORTION OF THE LINDA VISTA COMMUNITY PLAN AREA UNTIL AMENDMENTS TO THE LINDA VISTA COMMUNITY PLAN ARE ADOPTED AND IMPLEMENTING ORDINANCES ARE IN EFFECT.

Section 1. That this Council hereby repeals Interim Ordinance No. O-17167 (New Series).

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
