However, the Planning Director shall require additional landscaping that may be feasibly placed on the site or parkway according to City-wide landscape standards, and/or other architectural features or improvements.

The Planning Director shall in no case provide

VARIANCE AND DEVELOPMENT ADMINISTRATIVE REVIEW

On an individual project basis, an application for a variance may be approved when one or more of the following situations is applicable: (1) due to special conditions, or exceptional characteristics of the property, or of its location or surroundings, strict interpretation of the criteria of this ordinance would result in unusual difficulties or unnecessary hardship or would be inconsistent with the general purpose of this ordinance; or (2) a superior design can be achieved by altering the adopted standards; or (3) conformance with the "Guidelines for Discretionary Review" necessitates deviation from the adopted standards.

The Planning Director may conduct further review and approve or deny an application for an exception from the provisions of the San Ysidro Implementing Ordinance in accordance with "Process
