AN ORDINANCE AMENDING CHAPTER IV, ARTICLE 6, DIVISION 1, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 66.0107 RELATING TO THE COLLECTION, TRANSPORTATION AND DISPOSAL OF REFUSE.

WHEREAS, the City Council is considering an ordinance increasing the business license tax on refuse collectors and broadening the definition of refuse collectors; and

WHEREAS, that ordinance will require amendments to certain provisions of the San Diego Municipal Code which regulate the collection, transportation and disposal of refuse; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VI, Article 6, Division 1 of the San Diego Municipal Code be and the same is hereby amended by amending section 66.0107, to read as follows:

Section 66.0107 License Required for the Collection, Transportation and Disposal of Refuse

No change in subsection (a).

(b) Persons transporting refuse from their residences or persons who collect refuse in the course of City-approved community cleanup campaigns shall not be required to obtain a license tag or decal for their vehicles; provided, however, that such persons shall be required to transport

said refuse in the manner set forth in Section 66.0104.
Municipal corporations and other governmental agencies
engaged in the collection, transportation, or disposal or
refuse within the City of San Diego shall be exempt from the
license tag or decal requirements of this section.

Section 2. This ordinance shall take effect and be in force
on the thirtieth day from and after its passage.

AN ORDINANCE AMENDING CHAPTER IV, ARTICLE 6, DIVISION 1, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 68.0107 RELATING TO THE COLLECTION, TRANSPORTATION AND DISPOSAL OF REFUSE.

This ordinance amends the provisions of the City's regulatory scheme for refuse collection by deleting the exemption for those who heretofore have transported refuse produced in the course of their own business.
