Any juvenile convicted of willful misconduct in violation of Section 54.0405(a) shall serve not less than eight (8) hours and not more than eighty (80) hours of community service. One (1) parent or legal guardian shall be present at the community service site for at least one-half of the community service hours required of the juvenile.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.


