ORDINANCE NUMBER O- 18002 (NEW SERIES)

ADOPTED ON OCT 25 1993

AN ORDINANCE CONDITIONALLY REZONING 16.9 ACRES LOCATED SOUTH OF AERO DRIVE AND WEST OF INTERSTATE 15, IN THE KEARNY MESA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO. CALIFORNIA, FROM THE M1-A/M1-A(HR) ZONES INTO THE CA/CA(HR) ZONES, AND CONDITIONALLY REZONING 45.3 ACRES LOCATED SOUTH OF AERO DRIVE AND WEST OF INTERSTATE 15, IN THE KEARNY MESA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, FROM R1-40000 TO THE CA ZONE, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 101.0428, AND REPEALING ORDINANCE NO. 9586 (NEW SERIES), ADOPTED FEBRUARY 16, 1967 AND ORDINANCE NO. 0-16297 (NEW SERIES), ADOPTED OCTOBER 15, 1984, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that within three years of the effective date of this ordinance conditionally rezoning 16.9 acres located south of Aero Drive and west of Interstate 15, in the Kearny Mesa Community Plan area, in The City of San Diego, California, from the M1-A/M1-A(HR) zones into the CA/CA(HR) zones, designated "CA/CA(HR)" on Zone Map Drawing No. B-4029, all or any portion of the property is subdivided and a map or maps thereof duly submitted to the City, approved by the City, and thereafter recorded, and within such subdivision or subdivisions provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of San Diego Municipal Code section 101.0428

shall attach and become applicable to the said subdivided land, and the said subdivided land shall be incorporated into CA/CA(HR) zones, as described and defined by Section 101.0428, the boundary of such zone to be as indicated on Zone Map Drawing No. B-4029, filed in the office of the City Clerk as Document No 218002. Said zoning shall attach only to those areas included in the approved map as provided in this section.

Section 2. That in the event that within three years of the effective date of this ordinance conditionally rezoning 45.3 acres located south of Aero Drive and west of Interstate 15, in the Kearny Mesa Community Plan area, in The City of San Diego, California, from the R1-40000 zone into the CA zone, designated "CA" on Zone Map Drawing No. B-4029, all or any portion of the property is subdivided and a map or maps thereof duly submitted to the City, approved by the City, and thereafter recorded, and within such subdivision or subdivisions provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of San Diego Municipal Code section 101.0428 shall attach and become applicable to the said subdivided land, and the said subdivided land shall be incorporated into CA zone, as described and defined by Section 101.0428, the boundary of such zone to be as indicated on Zone Map Drawing No. B-4029, filed in the office of the City Clerk as Document No. 60-18002. Said zoning shall attach only to those areas included in the approved map as provided in this section.

Section 3. That in the event the zoning restrictions shall attach to the said land described in Section 1 of this ordinance, Ordinance No. 9586 (New Series), adopted February 16, 1967 and Ordinance No. 0-16297 (New Series) adopted October 15, 1984, shall be automatically repealed insofar as the same conflict with the rezoned uses of such land.

Section 4. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
