AN ORDINANCE CONDITIONALLY REZONING 87.7
ACRES LOCATED ON THE SOUTH SIDE OF PALM
AVENUE, THE EAST SIDE OF INTERSTATE 805 AND
THE NORTH SIDE OF DEL SOL BOULEVARD, IN THE
OTAY MESA COMMUNITY PLAN AREA, IN THE CITY OF
SAN DIEGO, CALIFORNIA, FROM THE A-1-10/HRO
ZONE INTO THE CA (COMMERCIAL) ZONE, AS
DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION
101.0428, AND REPEALING ORDINANCE NO. 10862
(NEW SERIES), ADOPTED JUNE 29, 1972, AND
ORDINANCE NO. 12704 (NEW SERIES), ADOPTED
JULY 23, 1979, OF THE ORDINANCES OF THE CITY
OF SAN DIEGO INSOFAR AS THE SAME CONFLICT
HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that within three years of the effective date of this ordinance conditionally rezoning 87.7 acres located on the south side of Palm Avenue, the east side of Interstate 805, and the north side of Del Sol Boulevard, in the Otay Mesa Community Plan area, in the City of San Diego, California, from the A-1-10 zone into the CA (Commercial) zone, designated "CA" on Zone Map Drawing No. B-4030, all or any portion of the property is subdivided and a map or maps thereof duly submitted to the City, approved by the City, and thereafter recorded, and within such subdivision or subdivisions provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of San Diego Municipal Code Section 101.0428 shall attach and become applicable to the said subdivided land, and the

said subdivided land shall be incorporated into the CA zone, as described and defined by Section 101.0428, the boundary of such zone to be as indicated on Zone Map Drawing No. B-4030, filed in the office of the City Clerk as Document No. 18007. Said zoning shall attach only to those areas included in the approved map as provided in this section.

Section 2. That in the event the zoning restrictions shall attach to the said land described in Section 1 of this ordinance, Ordinance No. 10862 (New Series), adopted June 29, 1972, and Ordinance No. 12704 (New Series), adopted July 23, 1979, shall be automatically repealed insofar as the same conflict with the rezoned uses of such land

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
