ORDINANCE NUMBER 0- 18013

(NEW SERIES)

AN ORDINANCE INCORPORATING PARCELS 1 AND 2 OF PARCEL MAP 15134, LOCATED NORTH OF THE FUTURE EXTENSION OF PALM AVENUE, EAST OF INTERSTATE 805, AND SOUTH AND WEST OF THE CITY OF CHULA VISTA, IN THE OTAY MESA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, FROM A-1-10 AND A-1-10/HR ZONES INTO THE A-1-1, R1-5000, AND R-1750 ZONES, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTIONS 101.0404, 101.0407 AND 101.0410, AND REPEALING ORDINANCE NO. 10862 (NEW SERIES), ADOPTED JUNE 29, 1972, AND ORDINANCE NO. 0-12704 (NEW SERIES) ADOPTED JULY 23, 1979, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that within three years of the effective date of this ordinance incorporating parcels 1 and 2 of Parcel Map 15134, located north of the future extension of Palm Avenue, east of Interstate 805, and south and west of the City of Chula Vista, in the Otay Mesa Community Plan area, in the City of San Diego, California, designated "A-1-1, R1-5000, and R-1750" on Zone Map Drawing No. C-854, is subdivided and a map or maps thereof duly submitted to the City and thereafter recorded, and within such subdivision or subdivisions provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of San Diego Municipal Code sections 101.0404, 101.0407 and 101.0410 shall attach and become applicable to the said subdivided land,

and the said subdivided land shall be incorporated into the A-1-1, R1-5000 and R-1750 Zones, as described and defined by Sections 101.0404, 101.0407 and 101.0410, the boundary of such zone to be as indicated on Zone Map Drawing No. C-854, filed in the office of the City Clerk as Document No. 20-18013. Said zoning shall attach only to those areas included in the map as provided in this section.

Section 2. That in the event the zoning restrictions shall attach to the said land described in Section 1. of this ordinance, Ordinance No. 10862 (New Series), adopted June 29, 1972, and Ordinance No. O-12704 (New Series), adopted July 23, 1979, be, and it is hereby repealed insofar as the same conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
