BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 3, Division 6, of the San Diego Municipal Code be and the same is hereby amended by amending Section 103.0610 to read as follows:

SEC. 103.0610 Commercial Zones

- A. through C. [No changes.]
- D. SPECIALIZED COMMERCIAL (SC)\

All paragraphs of Section 101.0428 (CA Zone) of the Municipal Code shall apply except that the following uses shall be prohibited:

- 1. Apartments
- 2. Truck Sales
- 3. Automobile wash establishments
- 4. Automobile repair and paint shops (including body and fender work if entirely within an enclosed building)
- 5. Boat and trailer sales agencies
- 6. Equipment and tool rental establishments
- 7. Frozen food lockers
- 8. Hotels, motels and time share projects.


