ADOPTED ON NOV 29 1993

AN ORDINANCE AMENDING CHAPTER X, ARTICLE 3, DIVISION 6, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 103.0610 RELATING TO THE CARMEL VALLEY PLANNED DISTRICT.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 3, Division 6, of the San Diego Municipal Code be and the same is hereby amended by amending Section 103.0610 to read as follows:

SEC. 103.0610 Commercial Zones

A. through C. [No changes.]

D. SPECIALIZED COMMERCIAL (SC)\

All paragraphs of Section 101.0428 (CA Zone) of the Municipal Code shall apply except that the following uses shall be prohibited:

1. Apartments
2. Truck Sales
3. Automobile wash establishments
4. Automobile repair and paint shops (including body and fender work if entirely within an enclosed building)
5. Boat and trailer sales agencies
6. Equipment and tool rental establishments
7. Frozen food lockers
8. Hotels, motels and time share projects.
