WHEREAS, Stu Segall Productions employs hundreds of San Diegans, both in front of and behind the cameras, including previously unemployed residents; and

WHEREAS, "Silk Stalkings" has been renewed for a second season of 22 episodes; and

WHEREAS, Stu Segall Productions will film a second series on location in San Diego titled "Renegade" starring Lorenzo Lamas; and

WHEREAS, Stu Segall Productions converted a warehouse on Ruffin Road into a television network sound stage that will assist San Diego in attracting future production thereby increasing the film industry's economic impact and employment in San Diego; and

WHEREAS, Stu Segall Productions has made significant contributions of expertise, and equipment to the San Diego Police Department's Anti-Drug Campaign to help produce a Public Service

Announcement; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of its citizens, does hereby recognize the accomplishments of Stu Segall and commend him for his commitment to community service.
