## RESOLUTION NUMBER R-280090 ADOPTED ON JUNE 8, 1992

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to negotiate, for and on behalf of said City, an agreement with The County of San Diego, for general animal control services in Fiscal Year 1993, under the terms and conditions specified in City Manager Report No. 92-186, dated May 29, 1992 and incorporate the panel service level indicators that are determined by the Public Services and Safety (PS&S) Committee and return to the Council with the contract for review.

BE IT FURTHER RESOLVED, that the City Manager is directed to return to the July 15, 1992 PS&S Committee meeting with a three phase economic analysis of the committee's findings to (a) establish the portions that are revenue enhancing; (b) establish the portions that can be immediately implemented at little or no cost; and (c) establish the portions that are medium and long term and require revenue enhancement.

BE IT FURTHER RESOLVED, that the City Manager is authorized to extend the Fiscal Year 1992 agreement on a month to month basis under the existing terms and conditions until the Fiscal Year 1993 agreement is executed.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$1,400,000 from Nondepartmental Expenditures

(Program 60101) is hereby authorized, solely and exclusively for

the purpose of providing funds for general animal control services during Fiscal Year 1993.

BE IT FURTHER RESOLVED, that the City Manager is directed to meet quarterly with the Blue Ribbon Panel to monitor the performance of the contract service level.
