RESOLUTION NUMBER R- 280184

ADOPTED ON JUN 22 1992

WHEREAS, the City of San Diego, through the San Diego Police Department has been selected to receive, and desires to accept and expend a grant award of five hundred thousand dollars (\$500,000.00) entitled "Drug Abuse Resistance Education (D.A.R.E.) Special Purpose Grant" from the United States Department of Housing and Urban Development; and

WHEREAS, the grant award will be used to develop and implement D.A.R.E. Day Camps in targeted low income, public, and subsidized housing areas throughout the City; and

WHEREAS, the Day Camps will provide a comprehensive anti-drug and gang curriculum and wholesome athletic activities to children ages eight to twelve (8 - 12), at fourteen (14) target sites, during summer, winter, spring, and off-track school breaks; and

WHEREAS, the grant will fund two (2) Community Service Officers, a thirty-six foot (36') motor home, and miscellaneous supplies and equipment for the Day Camps; and

WHEREAS, the grant will also provide for implementation of the Senior High School D.A.R.E. curriculum, with the first target school being Lincoln High School; and

WHEREAS, the grant will fund one (1) Police Officer, a van, and miscellaneous equipment and supplies for the D.A.R.E. Senior High School component; and

WHEREAS, there is no requirement for matching funds and all required personnel, equipment, and supplies will be funded by the grant; NOW THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be, and he is hereby authorized to submit the Grant Application Proposal, a copy of which is attached as Document No. RR-280184 to the United States Department of Housing and Urban Development, and he is further authorized to execute the grant proposal program, including any extensions or amendments thereof; and

BE IT FURTHER RESOLVED, that any liability arising out of the performance of the Grant Award Agreement, including civil court action for damages, shall be the responsibility of the grant recipient and the authorizing agency; the federal government, and the United States Department of Housing and Urban Development disclaims responsibility for any such liability;

BE IT FURTHER RESOLVED, that any grant funds received hereunder shall not be used to supplant expenditures controlled by this body.
