BE IT RESOLVED, by the Council of The City of San Diego that the specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF AERO DRIVE INDUSTRIAL PARK, on file in the office of the City Clerk of San Diego, California on JAN 04 1993, and bearing official Document No. W.O. 119129, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and she was hereby authorized and directed to proceed to publish in accordance with the law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF AERO DRIVE INDUSTRIAL PARK.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$149,869.00 from CIP 58-004.0, MISCELLANEOUS REQUIREMENTS - CITY STREETS (TransNet Fund 30300) to CIP 39-052.0, AERO DRIVE INDUSTRIAL PARK; and authorizing the expenditure of funds, not to exceed \$764,700.00 (\$229,494.00 new authorization from CIP 39-052.0; and \$149,869.00 transferred from CIP 58-004.0), from CIP 39-052.0, for the purpose of executing this contract and related costs.

BE IT FURTHER RESOLVED, that stated for the record, the City of San Diego as lead agency has reviewed and considered the final environmental document.

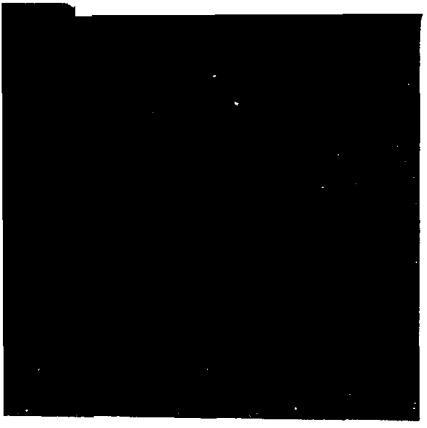
