BE IT RESOLVED, by the Council of The City of San Diego that the specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF EPOXY DECK TREATMENT OF WEST MISSION BAY DRIVE BRIDGE OVER THE MISSION BAY CHANNEL, San Diego, California, on file in the Office of the City Clerk of San Diego, California on JAN 04 1993, and bearing official document No. W.O.119901, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and she is hereby authorized and directed to proceed to re-publish in accordance with the law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to. This project was withdrawn from advertisement in order to revise the plans and specifications. The City will now re-advertise the project.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF EPOXY DECK TREATMENT OF WEST MISSION BAY DRIVE BRIDGE OVER THE MISSION BAY CHANNEL.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$537,000.00, releasing funds previously authorized per R-279688

and R-275960 totalling \$484,737.00 and requesting an additional \$52,263.00 from Gas Tax Fund 30219 appropriated in Bridge Maintenance Funds, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
