BE IT RESOLVED, by the Council of The City of San Diego, that the Fiscal Year 1993 CIP budget be and is hereby modified by adding the following projects:

CIP No. 29-798.0	Colina Del Sol Community Park - Security Lighting
CIP No. 29-799.0	Memorial Community Park - Security Lighting
CIP No. 29-800.0	South Bay Community Park - Parking Lot

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to make the following transfer of funds: \$35,000 from Fund No. 11610 to CIP No. 29-798.0, Colina Del Sol Community Park - Security Lighting; \$35,000 from Fund No. 79511 to CIP No. 29-799.0, Memorial Community Park - Security Lighting; and \$250,000 from Fund No. 11730 to CIP No. 29-800.0, South Bay Community Park - Parking Lot.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to use City Forces to construct security lighting at Colina Del Sol Community Park and Memorial Community Park.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$70,000, consisting of \$35,000 from CIP No. 29-798.0, Colina del Sol Community Park - Security Lighting, PSD Fund No. 11610, and \$35,000 from CIP No. 29-799.0, Memorial Community Park - Security Lighting, DIF Fund No. 79511, is hereby

authorized, solely and exclusively for the purpose of providing funds for the above lighting projects.
