

Soledad telecommunications facility, retroactive to July 1, 1992, at an annual cost to City of \$44,064, under the terms and conditions set forth in that lease agreement on file in the office of the City Clerk as Document No. RR- 281301.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$44,064 from Fund 100, Dept. 535, Org. 102, Account 4682, Job Order 5153, for Fiscal Year 1993 costs, is hereby authorized and approved.
