RESOLUTION NUMBER R-281311

ADOPTED ON JANUARY 5, 1993

WHEREAS, the California Government Code sections 65350 to 65362, inclusive, set forth State requirements for the preparation, adoption, and amendment of local general plans; and

WHEREAS, the State law and City Council Policy 600-7 require that consistency be maintained among the City's General Plan and the various community plans and other official planning-related documents, subject to the limitation of frequency of amendments to mandatory elements of the General Plan; and

WHEREAS, the planning actions (the "amendment") identified in Manager's Report No. P-93-004 dated December 22, 1992, a copy of which is on file in the office of the City Clerk as Document No. RR-281311, have been approved by the City Council between April 11, 1989 and April 22, 1992, but will not become effective until the General Plan is amended to be consistent with those actions; and


WHEREAS, the Planning Commission of The City of San Diego held a public hearing on October 8, 1992, to consider amending the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO to reflect these planning actions noted above; and

WHEREAS, the Planning Commission on October 8, 1992, adopted Resolution No. 1003-PC, approving and recommending that the Council of The City of San Diego adopt the proposed amendment to the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the amendment to the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO as set out in Manager's Report No. P-93-004 except for Item 10 (The Mission Bay Park Master Plan, Mission Valley Community Plan, Ocean Beach Precise Plan and Local Coastal Program Addendum and the Tierrasanta and University Community Plans), on file in the office of the City Clerk as Document No. RR-281311, be and the same is hereby adopted.

BE IT FURTHER RESOLVED, that City Council consideration of Item 10 of the planning actions identified in Manager's Report No. P-93-004 be continued to February 2, 1993.
