WHEREAS, in June, 1992, the City Council approved the City Manager's recommendation to hire contractors to identify businesses which operate without a business tax certificate; and

WHEREAS, in August, 1992, the City Treasurer advertised in three (3) local newspapers for requests for proposals to identify businesses in violation of San Diego business tax laws; and

WHEREAS, a panel of City staff and members of the business community reviewed the written proposals and interviewed the prospective contractors; and

WHEREAS, the panel selected two (2) contractors due to their access to business databases, experience performing similar activities, and the soundness of their methods; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a contract with OSCAR D. GARCIA AND ASSOCIATES, to identify and report businesses that are not paying the business tax or are underreporting the number of employees, for a term of one (1) year, to be funded from a percentage of the revenues collected as a result of their efforts, under the terms and conditions set forth in the Contract on file in the office of the City Clerk as Document No.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a contract with INSIDE PROSPECTS, to identify and report businesses that are not paying the business tax or are under-reporting the number of employees, for a term of one (1) year, to be funded from a percentage of the revenues collected as a result of their efforts, under the terms and conditions set forth in the Contract on file in the office of the City Clerk as Document No. RR-

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$72,000 from Fund No. 100, Object Account 9544, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
