BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$7,020 from Police Department Fund 100, Dept. 110, Org. 485, Object Account 4682, Job 111482, to cover costs for the period January 1, 1993, to June 30, 1993, is hereby authorized and approved.


