A RESOLUTION OF THE CITY OF SAN  
DIEGO DECLARING THE EXISTENCE OF A  
STATE OF EMERGENCY.

WHEREAS, San Diego Municipal Code section 51.0106 empowers the City Manager to proclaim the existence of a local emergency when the City Council is not in session; and

WHEREAS, the City Manager of The City of San Diego has found that conditions of extreme peril to the safety of persons and property have arisen within the City, caused by heavy rains, mud slides and severe urban flooding; and

WHEREAS, the City Manager of The City of San Diego has found that rain has caused conditions in Tijuana which constitute a significant threat to the health and safety to The City of San Diego and its citizens; and

WHEREAS, the Governor of California has proclaimed a state of emergency in San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that a local emergency exists throughout The City of San Diego.

BE IT FURTHER RESOLVED, that during the existence of this local emergency the powers, functions and duties of the City Manager of San Diego shall be those prescribed by State law and the Charter, ordinances, resolutions, and approved plans of The City of San Diego in order to mitigate the effect of this local emergency.

BE IT FURTHER RESOLVED, that the declaration by the Manager of The City of San Diego, pursuant to the authority of the Charter of The City of San Diego and Section 51.0106 of the San Diego Municipal Code, that a state of emergency exists within said City, be and it is hereby approved.
