BE IT RESOLVED, by the Council of The City of San Diego that the low bid of EL CAJON FORD, meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of ONE HUNDRED FOURTEEN (114) POLICE PATROL CARS (1993 Ford Crown Victoria Police Interceptor) at a cost of \$11,960.00 each, for a total combined cost of \$1,363,440.00; terms net 30 days, plus sales tax, less trade-in allowances as follows:
