BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and she is hereby authorized and directed to proceed to publish in accordance with the law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF ARIZONA STREET STORM DRAIN.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$25,000.00 from CIP No. 112590, MARKET STREET STORM DRAIN, Fund No. 30300, to CIP No. 170030, ANNUAL ALLOCATION - SEEPAGE PROBLEMS, Fund No. 30300; and authorizing the expenditure not to exceed \$98,114.00 from CIP No. 170030, Fund 30300 (TransNet Fees), for the purpose of executing this contract and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
