RESOLUTION NUMBER R- 281372

ADOPTED ON JAN 25 1993

WHEREAS, the Police Department of The City of San Diego wishes to accept and expend a donation of ten thousand dollars (\$10,000.00) from the James Hervey Johnson Charitable Educational Trust, a foundation established to promote abstinence from drugs, alcohol, and tobacco; and

WHEREAS, the donation will be used to purchase promotional supplies for the San Diego Police Department's Drug Abuse Resistance Education Program (DARE), the purpose of which is to promote abstinence from drugs, alcohol, and tobacco among children in San Diego; and

WHEREAS, there is no requirement for matching funds and no additional resources will be required to administer the use of the donation for the stated purposes; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be, and is hereby, authorized to accept and expend the donation, documentation of which is on file in the Office of the City Clerk, as Document No. RR- 281372 from the James Hervey Johnson Charitable Educational Trust, including any extensions or amendments thereof.

BE IT FURTHER RESOLVED, that any liability arising out of the use of the donation, including civil court action for damages, shall be the responsibility of the donation recipient and the authorizing agency; the James Hervey Johnson Charitable

Educational Trust, its administrators and affiliates, disclaim responsibility for any such liability.

BE IT FURTHER RESOLVED, that any funds received hereunder shall not be used to supplant expenditures controlled by this body.

BE IT FURTHER RESOLVED, that the City Council, on behalf of The City of San Diego and the San Diego Police Department, expresses gratitude to the James Hervey Johnson Charitable Educational Trust for this donation to San Diego DARE.
