BE IT RESOLVED, by the Council of The City of San Diego, that the payment of principal and premium on a lost registered bond for The City of San Diego 1915 Act Limited Obligation Bond, Certificate Number W074, Calle Cristobal Assessment District No. 4013, Bond Series 3668, Par Value \$5,000.00, called September 2, 1992, be and is hereby authorized.
